ARTICLES OF INCORPORATION OF TRI-COUNTY GYMNASTICS BOOSTER CLUB, INC.

Pursuant to the provisions of Florida Statutes Section 617.1006 the Tri-County Gymnastics Booster Club, Inc, a Florida Not-For-Profit Corporation adopts the following amendment:

The Articles of Incorporation are amended to add an additional Article to be labeled Article VIII which shall read as follows:

Upon dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Please of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
