Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:

1. AMENDMENT ADOPTED:

Article III, Purposes, is hereby deleted in its entirety and the following is inserted in lieu and in place thereof:

ARTICLE III Purposes

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations qualifying as an exempt organization from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. The charitable, religious, educational, and scientific purposes include, without limitation, the following:

- A. Providing financial assistance to lower income pet owners located in the Florida Keys for emergency veterinary care and services.
- B. Providing financial assistance to lower income pet owners located in the Florida Keys for annual veterinary visits, preventive medications and annual vaccinations.
- C. Promoting the health and welfare of pets in the Florida Keys by educating their owners on the importance of annual veterinary visits.
- 2. The date of adoption of the amendment was: April 30, 2008
- 3. There are no members or members entitled to vote on the amendment. The amendment was adopted by the Board of Directors.
