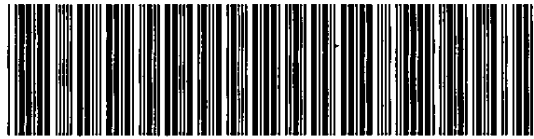

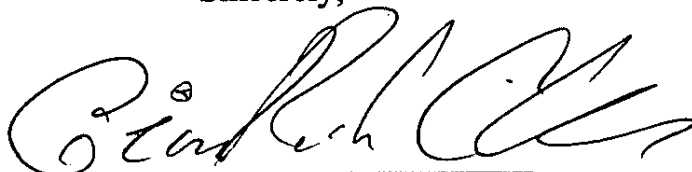

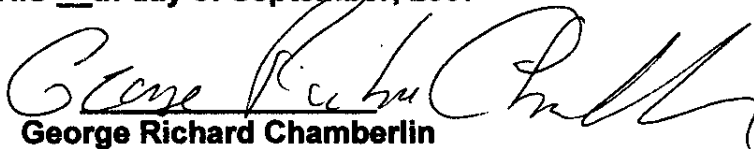

**ARTICLES OF INCORPORATION
OF
CHAMBERLIN ASSOCIATION OF AMERICA, INC.**

THE UNDERSIGNED, for the purpose of forming a corporation pursuant to Chapter 617, Florida Statutes, (Not For Profit) does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is:

CHAMBERLIN ASSOCIATION OF AMERICA, INC.

ARTICLE II

PURPOSES

The purpose or purposes for which the corporation is organized is as follows:

Said organization is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding

section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for the purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

ARTICLE III **MANNER OF ELECTION**

This directors of this corporation shall be elected as provided in the by-laws of this corporation.

ARTICLE IV **INITIAL DIRECTORS and/or OFFICERS**

This corporation shall have one director initially. The officers will be elected the first week in October, 2007 as provided by the by-laws. The number of directors may be either increased or diminished from time to time in the manner provided in the by-laws, but shall never be less than one.

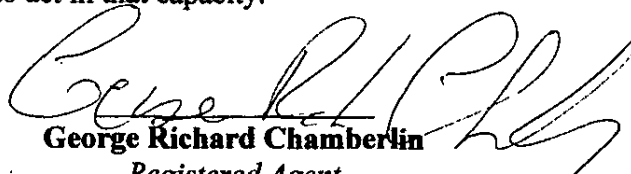

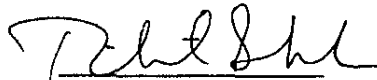
