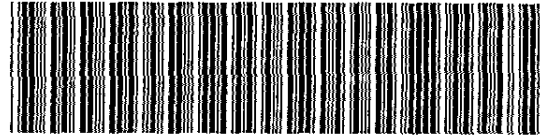

**ARTICLES OF INCORPORATION
OF
SAVING ONE CHILD AT A TIME, INC**

The undersigned subscriber to these articles of incorporation is a natural person competent to contract and hereby form a **nonprofit** corporation under chapter 617 of the Florida Statutes.

ARTICLE I
NAME

The name of this corporation shall be **SAVING ONE CHILD AT A TIME, INC** (herein after, "corporation").

ARTICLE II
PRINCIPAL OFFICE

The address of the principal of the corporation is 2325 Anacostia Avenue, Ocoee, FL 34761, and the mailing address is the same.

ARTICLE III
PURPOSE OF CORPORATION

The corporation is a nonprofit corporation organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. More specifically, the corporation will focus on child abuse by promoting awareness.

ARTICLE VI
BOARD OF DIRECTORS/TRUSTEES

A) Board of Directors: The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be a minimum of three (3), provided however, that maximum number shall be set and may be changed by the bylaws when duly adopted.

The directors named herein as the first board of directors shall hold office and serve in accordance with the bylaws, until the first meeting of the board, at which time an election of directors shall be held. Directors elected at the first meeting, and at all times thereafter, shall be elected and serve in accordance with the bylaws, and until the qualification of the successors in office.

ARTICLE VII
DEDICATION OF ASSETS

The assets of this corporation are irrevocably dedicated exclusively for charitable, religious, educational and scientific purposes as an exempt organization under Section 501© of the Internal Revenue Code or corresponding provisions of any subsequent federal law.

ARTICLE VIII
DISTRIBUTION OF ASSETS FOR ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefits of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or

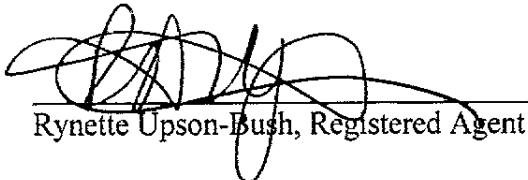
distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX
DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ACCEPTANCE OF REGISTERED AGENT DESIGNATED IN ARTICLES OF INCORPORATION

Having been named as registered agent and to accept service of process for the above stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.

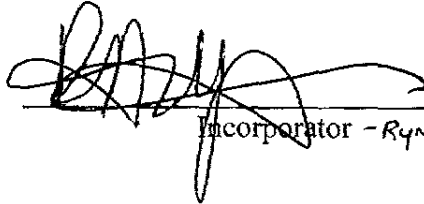

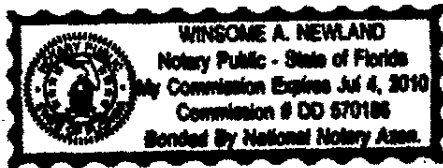
