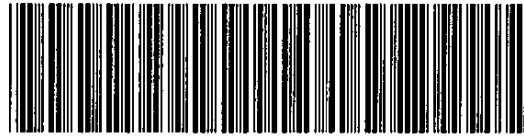

ARTICLES OF INCORPORATION  
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

The name of the corporation shall be:

**Victoria's Wish Foundation, Inc.**

ARTICLE II

The principle place of business and mailing address of this corporation shall be:

ARTICLE III

The purpose of which the corporation is organized is:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**This Foundation is based in whole in memory of Victoria Brandt (1998-2007). Victoria was the victim of a tragic automobile accident on February 19, 2007. In her time here, her enjoyment of life was bringing children together. She was an angel who had a gift of touching everyone she came in contact with. After school, Victoria would organize the kids in the neighborhood and have "After School" sessions. In these meetings, Victoria would help other children with school related activities in areas that they needed help with. Parents of these children would comment on how unbelievable she was in assisting their children with their curriculum. Victoria not only enjoyed teaching others, but giving to other children was her life. We couldn't stop her from giving her toys and clothes to children who seemed to have less than her. We would like to keep Victoria's wishes alive, continuing her short lived legacy with a long term commitment, in memory of her.**

a.) To provide peer to peer educational resources (i.e. computers, books, etc.) to families with financial hardships and non-profit institutions in need of equipment, enabling children with their continuing education and development.

b.) To organize indoor/outdoor activities for children in events that will bring children and families together.

d.) To assist families with children in financial crisis, with food, clothes, and any other resource that is deemed necessary.

1.) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

2.) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV

The manner in which the Directors are elected or appointed:

**Directors are elected by majority vote. If there is an even number of votes, there will be a vote to elect a non biased mediator who will act on behalf of the directors to make the final vote.**


