

Articles OF Amendment Articles OF Incorporation

NAME

The name of the Association shall be Maculelê Miami Brazilian Arts Institute, Inc. (hereinafter, the "MMBAI").

ARTICLE II

PRINCIPLE OFFICE AND MAILING ADDRESS

The principle place of business of MMBAI is Body Motion Institute, 12248 SW 131 Avenue, Miami, FL 33186. The mailing address of MMBAI is 10621 Hammocks Blvd, #432, Miami, FL 33196. Official records will be kept at 10621 Hammocks Blvd, #432, Miami, FL 33196; Copies of records will be kept at 12248 SW 131 Avenue, Miami, FL 33186.

ARTICLE III

PURPOSE

It is the mission of MMBAI to foster a knowledge of, and appreciation for, the rich history, tradition and fundamentals of Brazilian Arts through outreach and education efforts aimed at all socio-economic levels.

MMBAI is dedicated to the principle that anyone can learn, and will never tolerate discrimination on the basis of age, gender, social or economic status, or national origin while promoting this vision.

To this end, MMBAI will offer classes and support to at-risk youth in the greater Miami area and in Brazil. All-profits generated from the Institute's efforts will go directly to expanding and improving outreach programs, bringing teachers from Brazil to Miami, and rewarding dedicated students with sponsorship to Brazil.

ARTICLE IV

BOARD MEMBERS

MMBAI shall be managed under the direction of a Board which shall be comprised of a minimum of three (3) Members and not more than fifteen (15). The number of Members shall be set from time to time by the Board. The manner of election, qualification and powers of the Board shall be as set forth in the Bylaws of MMBAI. Board Members' duties include, but are not limited to, fundraising, voting on MMBAI related matters and attending all board meetings. Board Members have no personal or professional stake in or ownership of MMBAI nor will they be involved in the daily operations of the organization.

ARTICLE V

REGISTERED AGENT

The registered agent of Maculele Miami Brazilian Arts Institute, Inc. is Anne-Marie Shaffer, located at 13361 SW 47 Street, Miami, FL 33175.

ARTICLE VI

INCORPORATOR

The incorporator of Maculelê Miami Brazilian Arts Institute, Inc. is Joshua Broadhead, located at 10621 Hammocks Blvd. #432, Miami, FL 33196.

ARTICLE VIII

LIMITATIONS

No part of the net earnings of MMBAI shall inure to the benefit of, or be distributable to, its Board Members, members or other private persons, except that MMBAI shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. Notwithstanding any other provision of these Articles, MMBAI shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) on the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue code (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX

DISSOLUTION

Upon the dissolution or winding up of MMBAI, its assets remaining after payment, or provision for payment, of all debts and liabilities of MMBAI, shall be distributed exclusively for the purposes of MMBAI, or to one or more not-for-profit funds, foundations, or corporations which are organized and operated exclusively for charitable purposes and which have established its of their tax exempt status under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE X

AMENDMENTS

Amendments to the Articles of Incorporation of MMBAI may be proposed and adopted by its Board Members.

ARTICLE XI

BYLAWS

The Bylaws of MMBAI shall be made, amended, or rescinded by its Board Members.
