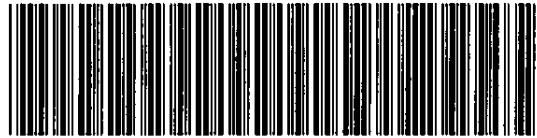

Article I
Name of Corporation

The name of the corporation shall be: ***"Eyes on the Sky's Community Services, Inc."***

Article II
Principal Office

The principal place of business and mailing address shall be: 2409 W. Ravine Drive, Ruskin, FL. 33570

Article III
Purpose

The purpose for which the corporation is organized is: "...to help people discover their full God given potential to become all they were created to be".

Article IV
Manner of Election

The manner in which the directors are elected or appointed: The initial Directors of the Corporation shall be appointed by the President of ***Eyes on the Sky's Community Services, Inc.*** and henceforth shall be elected by a majority vote of the Corporation on a yearly basis.

Article VIII
Limitations

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501 (C) (3) if the Internal Revenue Code of 1986, as now enacted or herein amended, nor to any Director or Officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation:

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 (C) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
4. The corporation shall not lend any of its assets to any officer or director of this corporation (unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-board members), or guarantee to any person the payment of a loan by an officer or director of this corporation.

Article IX

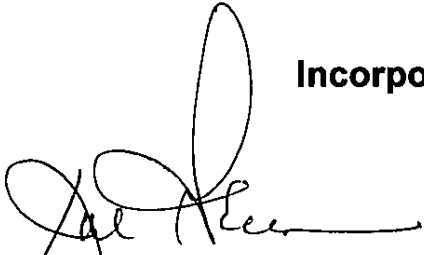
Debt Obligations and Personal Liability

No member, officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or directors be subject to the payment of the debts or obligations of this corporation.

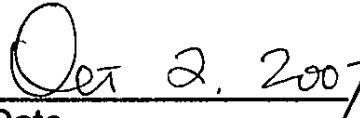
Article X Dissolution

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payments of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
