ARTICLES OF INCORPORATION
OF
MOUNT OLIVE PRIMITIVE BAPTIST CHURCH, INC.
A NOT FOR PROFIT FLORIDA CORPORATION

The undersigned incorporators hereby form a Not for Profit corporation under chapter 617 of the laws of the State of Florida

ARTICLE I
NAME / REGISTERED OFFICE

The name of the corporation shall be Mount Olive Primitive Baptist Church, Inc.

The address of the principal office of this corporation shall be 510 NE 15th Street, Gainesville, Alachua County, Florida 32641-1526, and the mailing address of the corporation shall be the 510 NE 15th Street, Gainesville, Florida 32641-1526.

ARTICLE II
EXISTENCE

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation with the office of the Secretary of State of the State of Florida and the corporation shall have perpetual existence thereafter.

ARTICLE III

PURPOSE

This corporation is organized exclusively for religious, charitable, scientific, and educational purposes, within the meaning of Section 501(c) (3) of the United States Internal Revenue Service Code as amended.

This corporation shall have all powers granted generally including, but not limited to, the following:

- A. The purpose of Mount Olive Primitive Baptist Church, Inc. is to provide religious, charitable, scientific, and educational activities.
- B. To receive, maintain, and accept as assets of the corporation, and property, whether real, personal or mixed, by way of gift, bequest, devise, or purchase from any person, firm, trust or corporation, to be held, administered, and disposed of exclusively for charitable , religious, educational and scientific purposes within the meaning of Section 501(C)(3), of the Internal "Revenue Code, as amended, and in accordance with and pursuant to the provisions of the Articles of Incorporation, but no gift, bequest, devise or purchase of any such property shall be received or made and accepted if it is conditioned or limited in such a manner as shall require the disposition of income or principal to any organization other than a "charitable organization" or for a purpose other than a 'charitable purpose" which would jeopardize the status of the corporation as an entity exempt from federal income tax pursuant to the relevant provisions of the internal "Revenue Code, as amended;

- C. To exclusively promote and carry on any other religious, charitable, scientific or educational purposes and activities for which corporations may be organized and operated under the relevant provisions of the Internal Revenue Code, as amended, and under the Florida not for Profit Corporation code;
- D. To exercise all rights and powers conferred by the laws of the State of Florida upon not for profit corporation, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease, or otherwise any property of any sort or nature without limitations as to its amount or value and to hold, invest, reinvest, manage, use, supply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate, or other-wise dispose, of such property and the income principal proceeds or such proceeds for any of the purposes set forth herein; and
- E. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

ARTICLE IV

DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its officers and the board of directors subject to any limitations set forth in these Articles of Incorporation and the By-Laws.

The number of directors may be increased or decreased from time to time in the manner provided for in the bylaws of the corporation, provided that the corporation shall always have at least three (3) directors. Initially this corporation shall have nine (9) directors, who are;

ARTICLE VI

DEBT OBLIGATIONS AND PERSONAL LIABILITY

The corporation may indemnify any and all of its directors and officers, any former directors and former officers against expenses incurred by them, including legal fees or judgments or penalties rendered or levied against any such person in any legal action brought against any such person for actions of omissions alleged to have been committed by any such person while a director or an officer of the corporation, provided that the Board of Directors shall determine in good faith that such person did not act, fail to act, or refuse to act willfully or with gross negligence or with fraudulent or criminal intent in regard to the matter involved in the action.

This article is made a part of these articles to comply with and to take full advantage of the Florida State Laws governing such indemnification. This article is not intended to impose a limitation or requirement upon the Board of Directors nor is it intended to impair or limit in any way the immunity provisions found in Chapter 617 of the Florida Statutes.

Article IX
MEMBERSHIP

The authorized number, qualifications, and manner of admissions of members of this corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, the liability of members for dues and/or assessments and the method of collection thereof, and the termination and transfer of membership shall be as set forth in the bylaws of this corporation.

ARTICLE IX
DISSOLUTION

In the event that any assets are not disposed of in accordance with the provisions of these Articles of Incorporation

Articles of Incorporation, the Circuit Court of Alachua County, shall, upon application of one (1) or more persons having a real interest in the corporation or its assets, make such distribution as provided in these Articles of Incorporation.

ARTICLE X AMENDMENTS

Amendments to these Articles of Incorporation or By-Laws of the corporation shall be proposed by the Board of Directors and approved by majority of the members present at a regular notice meeting of the corporation which shall be held at such time and place as established by the Board of Directors or by the Bylaws.


