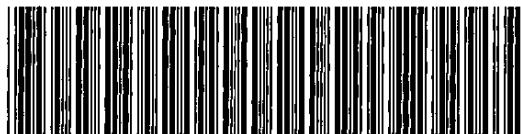

ARTICLES OF INCORPORATION

The undersigned being of legal age and competent to contract, for the purpose of organizing a non-profit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of the WAKE-UP Mentoring, Incorporation, in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

Article I Name

Wake-Up Mentoring, Inc. (Hereinafter a non-profit corporation).

Article II Principal Place of Business

The principal place of business for the WAKE-UP Mentoring, Inc. shall be at –
Dr. I. Sylvester Hankins Park Recreation Site, 1340 Lake Park Court, Orlando, FL 32805

The property and assets of this program are irrevocable dedicated to Charitable, Educational and Literary purposes.

Article III Purpose:

The business, if granted corporate status will commence its operation as a non-profit charitable, educational and mentoring organization operating in the state of Florida. The intent of this corporation is to participate in community awareness for the neighboring kids; Our goal is to 1) Encourage school success—attendance, good citizenship; completion of high school and college prep coursework 2) work with at-risk youths; 3) To build self-esteem ; 4) develop sound decision making skills and the understanding of finances; 5) To serve as mentors and role-models to facilitate their growth into productive members of society; 6) Assist with job placement; 7) Assist with difficult social, school and family issues; The program will also provide school clothing, hair cut, Christmas gifts, and birthday gifts.

Article IV Membership

Membership shall be established if the Organization decides whether or not it will intake new members.

Article VII Indemnification

In addition any rights and duties under applicable law, the Organization shall indemnify and hold harmless all its directors, officers, employees and agents from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such except for willful misconduct and gross negligence.

Article VIII By-Laws

Except as otherwise provided by law, the power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors.

Article IX Dissolution

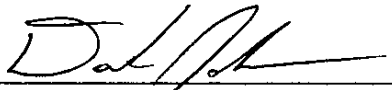
Upon the dissolution of the Organization, the Board of Directors shall after paying or making provision for the payment of all the liabilities of the Organization dispose of all of the assets of the Organization exclusively for the purposes of the Organization in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or literary purposes as shall at the time qualify as an exempt organization or organizations under Section 501 C3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of the Circuit Court of the city or county in which the principal office of the Organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
