FOR
CHRISTIAN COALITION AGAINST DOMESTIC ABUSE, INC.

ARTICLE I: NAME

The name of the corporation shall be **CHRISTIAN COALITION AGAINST DOMESTIC ABUSE, INC.**

ARTICLE II: PRINCIPLE OFFICE

The principal place of business address of this corporation shall be 2700 North 29th Avenue, #232, Hollywood, FL 33020 and the mailing address shall be 850 Ives Dairy Road T-57/409, North Miami, Beach, FL 33179.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, religious, educational and including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be by a simple majority of the qualified voting members.

ARTICLE V: INITIAL DIRECTORS AND/OR OFFICERS

ARTICLE IV: EARNINGS/ACTIVITIES OF CORPORATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized

and empowered to pay reasonable compensation for services rendered to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE V: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes with in the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI: INITIAL REGISTERED AGENT AND STREET ADDRESS
