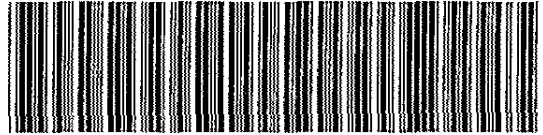

**ARTICLES OF INCORPORATION  
OF  
ALVA GREEN LEARNING CENTER, INC.**

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, Chapter 617, F.S., (Not for Profit), do hereby certify:

**ARTICLE I. NAME**

The name of the corporation shall be: Alva Green Learning Center, Inc.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 20150 North River Road, Alva, Florida 33920.

**ARTICLE III. PURPOSE**

The specific purpose or purposes for which the corporation is organized shall be to manage an educational facility at 20150 North River Road, Alva, Florida, where people can observe and learn to design, build and improve homes to conserve energy and water and be healthier places to live. Said corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV. MEMBERS**

The corporation may have one or more classes of members. The By-Laws shall contain provisions designating the class or classes of members and stating the qualifications and rights of members of each class.

**ARTICLE V. BOARD OF DIRECTORS**

The affairs of the corporation shall be managed by its Board of Directors. There shall not be less than three Directors. The number of Directors, and their powers, duties and terms of office shall be set forth in the By-Laws of the corporation. The Directors shall be elected annually by the Members of the corporation at the Annual Meeting of the corporation.

**ARTICLE VI. INITIAL DIRECTORS AND/OR OFFICERS**

#### **ARTICLE VIII. LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IX. DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
