

#### ARTICLE I—NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is THE HOUSE OF THE EPSILON OMEGA ZETA OF LAMBDA CHI ALPHA FRATERNITY, INCORPORATED, and its principal place of business shall be located at 5900 San Amaro Drive, Coral Gables, Florida 33146.
