

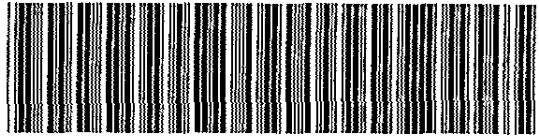

ARTICLE I—NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is THE HOUSE OF THE EPSILON OMEGA ZETA OF LAMBDA CHI ALPHA FRATERNITY, INCORPORATED , and its principal place of business shall be located at 5900 San Amaro Drive, Coral Gables, Florida 33146.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

The activities of the corporation shall be for the purpose of promoting, erecting, operating, and maintaining a housing facility for the student members of Lambda Chi Alpha Fraternity, at the University of Miami, Coral Gables, Florida, and for furnishing and equipping of said housing facility
