



**ARTICLES OF INCORPORATION  
OF  
JUST US MAKING PEOPLE INDEPENDENT NETWORK, INC.  
(A Florida Not-For-Profit Corporation)**

Articles of Incorporation of the understood, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**ARTICLE I**

The name of the Corporation shall be Just Us Making People Independent Network, Inc.

**ARTICLE II**

The principle office and mailing address of the Corporation shall be 6845 Landings Drive #111 Lauderhill, Florida 33319.

**ARTICLE III**

Said Corporation is organized as a non-profit organization organized exclusively for charitable, scientific and educational purposes, more specifically to help scaffold marginal and low-income participants socially and economically to provide supportive services in the form of parenting, job/educational training, affordable day care, public health interventions and other basic necessities as determined appropriate for the population being served. The Corporation may receive and disburse funds or other property incidents to or necessary for the accomplishment of the aforesaid purpose and do any and all acts of incidental to the transaction of the business of this Corporation of expedient for the attainment of the purposes stated herein. For such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV**

No part of the net earnings of the Corporation shall insure inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three thereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for pubic office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

Corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE V**

The Corporation shall commence its existence with the filing of these Articles of Incorporation. The Corporation shall exist perpetually, unless dissolved according to law.

#### **ARTICLE VI**

This Corporation shall not have members with voting rights. The Board of Directors may establish a class or classes of non-voting members upon such conditions and terms, as it from time to time deems appropriate.

#### **ARTICLE VII**

The street address of the initial registered office of the Corporation is 6845 Landings Drive #1111 Lauderhill, FL 33319, and the name of the Corporation's initial registered agent at that address is Paulette R Arline MPH.

#### **ARTICLE VIII**

The affairs of the Corporation shall be managed by a Board of Directors consisting of not less than five directors. The number of directors and the manner of election of directors shall be as set forth in the Bylaws.

#### **ARTICLE IX**

#### **ARTICLE X**

This Corporation may be dissolved in accordance with the laws of the State of Florida. Upon dissolution of this Corporation any surplus property remaining after the payment of its debts shall be disposed by transfer to one or more corporations, associations, institutions, trusts, or foundations organized and operated for one or more of the purposes of this Corporation, and described in Section 501 (c)(3) or the Internal Revenue Code or as to the State of Florida or any political party.

**ARTICLE XI**

The Directors of this Corporation shall not be personally liable for the debts or obligations of this Corporation of any nature whatsoever, nor shall any of the property of the Directors or Officers be subject to the payment of the debts or obligations of this Corporation to any extent whatsoever.

**ARTICLE XII**

These Articles of Incorporation may be amended only by the members of the Corporation.

**Articles XIII**

Bylaws for the Corporation shall be adopted by, and maybe amended only by, the Members of the Corporation.


