

ARTICLES OF INCORPORATION FOR JAMAICA, INC.

(A Corporation Not for Profit)



The undersigned hereby submit the following Articles of Incorporation for the formation in a corporation not-for-profit in accordance with the laws in the State of Florida.

I <u>NAME</u>

The name of the corporation shall be FOR JAMAICA, INC. (The "Corporation").

II <u>ADDRESS</u>

The address of the principal office of the Corporation and the mailing address of the Corporation shall be 11601 NW 6 Place, Plantation, Florida 33325, but the Corporation may maintain offices and transact business in other places within or without the State of Florida as may from time to time be designated by the Board of Directors. Furthermore, the Board of Directors may from time to time relocate the principal office of the Corporation.

III PURPOSE

To provide spiritual, medical, physical and cultural assistance to the poor in the especially abused, abandoned and neglected young Jamaican women in the following manner:

- a. To provide food, medicine and living necessities for the poor especially Jamaican women who are abused and abandoned, physically disabled or mentally impaired.
- b. To provide educational assistance for the poor especially abused and abandoned Jamaican women.
- c. To provide spiritual comfort through the provision of religious programs, prayers and devotions for the poor.
- d. To serve the community as a whole by serving the poor, providing food and comfort for the poor, providing shelter for the homeless, caring for orphans and assisting in their adoption.
- e. To attempt to reduce violence toward the abused and abandoned, especially Jamaican women, and improve the quality of life in the community through prayer, spiritual enrichment, education and counseling.

IV DIRECTORS

The governing body of this Corporation shall be the Board of Directors. The Board of Directors of FOR JAMAICA, INC. shall be elected or appointed in accordance with the Bylaws of the Corporation.

V REGISTERED AGENT

The registered office of FOR JAMAICA, INC. shall be located 6401 Lyons Road, Coconut Creek, Florida 33073. The name and address of the initial registered agent of FOR JAMAICA, INC. is David T. Price, Esq., 6401 Lyons Road, Coconut Creek, Florida 33073.

VI <u>DIRECTORS</u>

VII <u>OFFICERS</u>

The affairs of this Corporation shall be managed on a day-to-day basis by the officers in accordance with the Bylaws. The officers shall be appointed from time to time by the Board of Directors. Officers shall serve at the pleasure of the Board of Directors.

VIII DISSOLUTION

Upon dissolution of this Corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any further Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

IX DURATION

The Corporation shall have perpetual existence.

X BYLAWS

The first Bylaws shall be adopted by the directors and may be altered, amended or rescinded by the directors in the manner provided by the Bylaws.

XI <u>AMENDMENTS</u>

These Articles may be amended or repealed, in whole or in part, by a majority vote at any duly organized meeting of the directors.

XII CHARITABLE RESTRICTIONS AND LIMITATIONS

- 1. No part of the net earnings of FOR JAMAICA, INC. shall enure to the benefit of or be distributed to its governing Board of Directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payment and distribution in furtherance of the purposes set forth in Article III hereof.
- 2. The Corporation shall not attempt to influence legislation as a substantial part of its activities, nor shall it participate to any extent in any political campaign for or against any candidate for public office.
- 3. It is intended that this Corporation shall have the status of a Corporation which is exempt from Federal income taxation under Section 501 (a) of the Internal Revenue Code, as an organization described in Section 501 (c) (3) of the Code, and described in section 509 (a) (3) of the Code. These articles shall be construed accordingly, and all powers and activities of the corporation shall be limited accordingly.
 - 4. At no time shall the Board of Directors of the Corporation be constituted so as to be

controlled directly or indirectly by one or more disqualified persons with respect to the Corporation (as defined in Section 4946 of the Code) other than "foundation managers" as defined by the Code.

XIII UNRELATED BUSINESS ACTIVITY

Notwithstanding any other provision of these Articles of Incorporation, FOR JAMAICA, INC., shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under the provisions of Sections 501 (c) (3) of the Internal Revenue Code as amended or the corresponding provision of any future United States Internal Revenue Code provision or other activities which are prohibited to a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code as amended or the corresponding provision of any future United States Internal Revenue Code provision or other activities which are prohibited to a corporation.
