The Undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Association of Contractors & Code Professionals, Inc**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The purposes for which the Corporation is organized are exclusively charitable, scientific, or educational, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future United States Internal Revenue Law (the "Code").
