

RESOLUTION OF THE BYLAWS COMMITTEE OF THE FLORIDA ALLIANCE FOR RETIRED AMERICANS

WHEREAS, the Florida Alliance for Retired Americans (FLARA) was created as a not-for-profit organization exclusively for educational and charitable activities qualifying it for an exemption from federal income tax under Section 501(c)(3) of the Internal Revenue Code (Code), as reflected in FLARA's original Articles of Incorporation and its ByLaws, and

WHEREAS, the FLARA has determined that a 501(c)(4) organization would be a superior vehicle to advance the interests of Florida retirees.

NOW THEREFORE,

BE IT RESOLVED, that FLARA shall take all necessary steps to dissolve at this convention.

BE IT FURTHER RESOLVED, that the President or Treasurer of the Florida Alliance shall cause any funds held by the corporation, after all payments are made for services rendered or obligations satisfied, to be donated to the Alliance for Retired Americans Educational Fund, a not-for-profit organization exempt from federal taxation under 501(c)(3) of the Code, and any equipment, furniture or other assets owned by FLARA to be donated to an organization with a 501(c)(3) tax exemption or to be sold at fair market value to an organization that does not have a 501(c)(3) tax exemption.
