



### Amendment to Articles of Incorporation

[Underlined text indicates new text. Stricken text indicates deleted text.]

### Article VI

Section 1. The affairs of the corporation shall be managed and governed by a Board of Administrators composed of not less than three(3) five (5) not more than the number specified in the Bylaws. The administrators elected, subsequent to the recording of this amendment first Board of Administrators, shall be elected at the annual meeting of the membership, for a term of two (2) one (1) years, or until their successors shall be elected and qualify. Provisions for such election, and provisions respecting the removal, disqualification and resignation of administrators and for filling vacancies shall be established by the bylaws.
