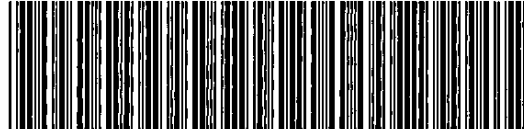

**ARTICLES OF INCORPORATION  
OF  
FLORIDA TAXPAYERS ASSOCIATION-ECO, INC.  
A Florida Not For Profit Corporation**

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby states:

**ARTICLE I – NAME OF CORPORATION**

The name of the corporation is: Florida Taxpayers Association-ECO, Inc. (hereinafter referred to as the "Corporation.")

**ARTICLE II – PRINCIPLE OFFICE**

The street address of the initial principal office and mailing address of the Corporation is: 1224 Greensward Drive, Tallahassee, Florida 32312. The Corporation may from time to time move its principal office to another location.

**ARTICLE III – PURPOSES OF THE CORPORATION**

The purposes for which the Corporation was formed are to:

- A. Facilitate the discussion of public policy issues of importance to the citizens of the State of Florida.
- B. Inform the citizens of the State of Florida through various means, including without limitation, the production of advertisements or direct mailings, of public policy issues of importance.
- C. Carry on any and all activities permitted to a corporation not for profit under the laws of the State of Florida that are consistent with Section 527.

**ARTICLE IV – ELECTION OF DIRECTORS**

The directors of the Corporation shall be elected as provided in the bylaws of the Corporation.

#### **ARTICLE VIII – CONFLICT OF INTEREST**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. Notwithstanding any other provision of these articles, this Corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

#### **ARTICLE IX—DISTRIBUTION OF ASSETS**

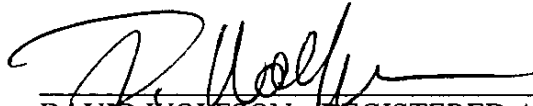
In the event of the dissolution or final liquidation of the corporation, all of the remaining assets and property of the corporation shall, after paying or making provision for the payment of all the liabilities and obligations of the corporation and for necessary expenses thereof, be distributed to such individuals as determined by the directors for the purposes set forth in Article III hereof. In no event shall any of such assets or property be distributed to any officer or director of the corporation or to any private individual.

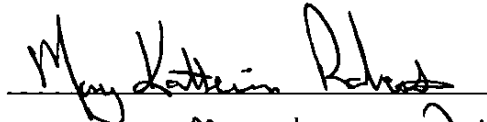
