- ONE:** The name and address of this principal corporation is Church of Unity #2, Inc. 74 NE 117th Street Miami, Florida 33161, in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This Corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under Nonprofit Religious Benefit Corporation Law for, Religious and Charitable purposes. To establish structured support services for Evangelistic, Prayer, and Other Ministries to support the outreach Ministries for the Body of Jesus Christ (The Church). This Church is an "affiliate" of Church of Unity, Inc. to conduct religious services, to minister at nursing homes, drug rehabilitation centers, prisons, feed and clothe the hungry, establish an intercessory unit, and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, unless dissolved according to law.
- FOUR:** The address of the Registered Office is 74 NE 117th Street Miami, Florida 33161, and the name and address of the registered agent of the corporation.


