Pursuant to Section 617.1006 of the Florida Not For Profit Corporation Act, the Articles of Incorporation of SEMINOLE YOUTHBUILD, INC. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is SEMINOLE YOUTHBUILD, INC.

SECOND: Article 1 of the Articles of Incorporation is amended in its entirety to read as follows:

"The name of the corporation shall be:

Seminole Youth Network, Inc."

THIRD: The foregoing amendment was adopted by a majority of a quorum of the Board of Directors of the Corporation by Resolution dated January 18, 2012. The Corporation has no Members.
