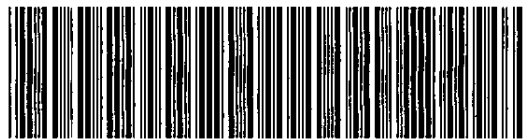

PURSUANT TO THE PROVISION OF SECTION 617,1006. FLORIDA STATUES.  
THE UNDERSIGNED FLORIDA NONPROFIT, CORPORATION ADOPTS THE  
FOLLOWING ARTICLES OF AMENDMENT TO ITS ARTICLES OF  
INCORPORATION.

FIRST AMENDED ADOPTED:

THE PURPOSE:

THE ORGANIZATION (KITCHEN FOUNDATION, CORP) IS ORGANIZED  
EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND/OR  
SCIENTIFIC PURPOSE UNDER SECTION 501 ©(3) OF THE INTERNAL  
REVENUE CODE.

SECOND AMENDED ADOPTED:

NO PART OF THE NET EARNING OF THE ORGANIZATION SHALL INURE TO THE  
BENEFIT OF, OR BE DISTRIBUTABLE TO, IT MEMBERS, TRUSTEE, OFFICERS OR  
OTHER PRIVATE PERSONS, EXCEPT THAT THE ORGANIZATION SHALL BE  
AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR  
SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN  
FURTHERANCE OF THE PURPOSE SE FORTH IN THE PURPOSE CLAUSE  
HEREOF. NO SUBSTANTIAL PART OF ACTIVITIES OF THE ORGANIZATION  
SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING  
TO INFLUENCE LEGISLATION, AND THE ORGANIZATION SHALL NOT  
PARTICIPATE IN OR INTERVENE IN(INCLUDING THE PUBLISHING OR  
DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF  
ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER  
PROVISION OF THIS DOCUMENT, THE ORGANIZATION SHALL NOT CARRY ON  
ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY AN  
ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION  
501 (C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING  
SECTION OF ANY FUTURE FEDERAL TAX CODE OR BY(B) BY AN  
ORGANIZATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER  
SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING  
SECTION OF ANY FUTURE FEDERAL TAX CODE.

THIRD ADOPTED AMENDMENT:

UPON THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSE WITHIN THE MEANING OF SECTION 501 © (3) IF THE INTERNAL REVENUE CODE OR CORRESPONDING SECTION OF ANY FUTURE TAX CODE OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OF LOCAL GOVERNMENT, FOR PUBLIC PURPOSE.


