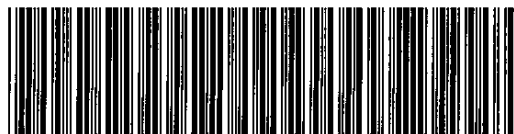

**ARTICLE I - CORPORATION NAME**

The name of the corporation shall be:

Born Again Church Of God In Christ Of Auburndale Fl, Inc.

**ARTICLE II      PRINCIPAL OFFICE**

**ARTICLE III      PURPOSE AND VISION**

The general purpose of this corporation is to implement its New Testament Commission by these prerogatives.

- (A) To administer the regular ordinances defined in the bylaws.
- (B) To establish and maintain such departments institutions and services within the church for the purposes of the corporation.
- (C) To examine candidates for the ministry and to license and ordain those who shall have been approved by the Pastor and appointed committee of their church according to the standards set forth by the New Testament.
- (D) To examine candidates, appoint Missionaries, and to endorse and support and support Missionary programs according to the standards set forth by the new testament.
- (E) To aggressively evangelized the world and establish and maintain religious worship, to build and maintain churches, parsonages, schools, hospitals, chapels and such other religious educational and benevolent institutions as may be necessary or proper.

(F) To maintain Missionary undertaking in the United States or in any foreign country and to perform all other acts according to standards set forth by the New Testament and as prescribed by and permitted under the law of the state of Florida. To accomplish the general purpose and objectives.

(G) To designate its own officers to appoint committees to arrange for its own meeting and to govern itself in accordance with the by laws.

(H) To establish and define by which it shall be govern.

## SECTION 2 INTERNAL REVENUE SERVICE

(A) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of tax future United States Internal Revenue Law.

(B) For charitable christian educational and scientific purpose including for such purposes, the making of distribution to organizations that qualify as exempt organizations under 501(C) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue Law.

## **ARTICLE IV MEMBERSHIP**

The manner in which the directors are elected or appointed:

Members of the corporation will be required to meet the following qualifications to wit to accept and agree to submit to:

(1) The purpose of the Corporation as set out in the Articles of Incorporation

(2) The tenets of faith

(3) The requirements for membership as set out and regulated by the by laws which may be herein and/or hereafter amended. Persons meeting such qualifications will be admitted by approval by the Board of Directors

provided however, that neither members nor directors of the Corporation shall have any vested rights, interest or privileges of in or to the assets, functions affairs or franchises of this Corporation or any rights interest or privilege which may be inheritable or which shall continue after his membership ceases in the forwarded Corporation.

(4) The Born Again Church Of God In Christ method of election of Directors is by voting active members of our church. This is in accordance with the by laws .
