# A Non-Profit Corporation

### ARTICLE I NAME

The name of this Corporation is PELICAN POINTE WOMEN'S ASSOCIATION, INC.

#### ARTICLE II PRINCIPAL OFFICE

The address of the principal office and the mailing address of the corporation is 754 Back Nine Drive, Venice, FL 34285.

#### ARTICLE III PURPOSE

The general nature of the objects and purpose of this Corporation shall be:

- (a) The purpose of the Club is to foster a spirit of community for all women living in Pelican Ponte. The objective is to make membership available to all women living in Pelican Pointe.
- (b) The Club shall be nonpartisan, nonsectarian, and shall not sponsor any legislative activities.

The Corporation shall issue no stock. No part of the net earnings of this Corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Article. In the event the Corporation should cease to exist, after all debts are paid, the Executive Board will distribute all remaining funds to one or more organizations that are exempt under Section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE V MANNER OF ELECTION

The business affairs of this Corporation shall be managed by the Board of Directors. The Directors shall consist of the Executive Board -President, Vice President, Secretary, Treasurer and the Past President, as advisor and the standing committees of Membership, Newsletter and Interest Group Coordinators, as will as any other committees deemed necessary by the Executive Board. A Nominating Committee will prepare a slate of officers. The slate shall be submitted to the membership with the notice of the annual meeting. The method of election of the Board shall be as stated in the Bylaws by an affirmative vote of a majority of members present at the annual meeting.
