**ARTICLES OF INCORPORATION**

The undersigned, desiring to form a corporation not for profit under Chapter 617, Florida Statutes, does ordain and establish these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be **FLORIDA CUB FLYERS, INC.**

ARTICLE II

The initial street address of the principle office of the corporation is **10906 Denoew Road, Boynton Beach, Florida 33472**, and the initial mailing address is **10906 Denoew Road, Boynton Beach, Florida 33472**.

ARTICLE III

The purposes for which the corporation is organized are as follows:

- (a) To foster, promote and encourage public interest in the preservation, reservation, use and knowledge of the Piper Cub series of aircraft as well other "Cub" designated aircraft;
- (b) To promote and stage meetings and gatherings of persons owning the Piper Cub series of aircraft and other "Cub" designated aircraft.
- (c) To promote and stage meetings and gatherings of persons interested in the Piper Cub series of aircraft as well as other "Cub" designated aircraft;
- (d) To prepare and publish literary pieces pertaining to the Piper Cub series of aircraft and other "Cub" designated aircraft;
- (e) To own, construct, purchase or otherwise acquire such property of interests as shall be necessary to carry out the purposes of the corporation, and;
- (f) To do and perform other acts and functions in furtherance of the purposes hereinabove expressed.

#### ARTICLE IV

The method of election of directors will be as stated in the bylaws of the corporation.

#### ARTICLE V

The street address of the corporation's initial registered offices is **c/o Jarvis & Associates, P.A., 1500 San Remo, Suite 145, Coral Gables, Florida 33146**, and the name of the initial registered agent at the address is **James W. Jarvis**.

#### ARTICLE VI

The name and address of the sole incorporator of the corporation is **Laurence W. Robinson Executive Director, 10906 Denoer Road, Boynton Beach, Florida 33472**.

#### ARTICLE VII

- (a) No part of the earnings of the corporation shall inure to the benefit of any member, director, or officer of the corporation, nor to the benefit of any private individual;
- (b) The corporation shall have no power to act or engage in any act or activity prohibited to corporations which are exempt from federal income taxation under Section 501(c)(6) of the Internal Revenue Code of 1986 or corresponding Sections of any prior or future Internal Revenue Code;
- (c) In the event of dissolution of the corporation, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt from organizations described in Section 501(c)(6) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any prior or future Internal Revenue Code, or to the federal or to the state or local government for public purposes exclusively.


#### ARTICLE VIII

These Articles of Incorporation may be amended by a two-thirds vote of the members. The initial by-laws of the corporation may be adopted by majority vote of the Directors present at a meeting of the Board of Directors at which a quorum is present, but the by-laws shall not thereafter be altered, amended, or repealed except by a majority vote of the members.

ARTICLE IX


The Articles of Incorporation shall become effective as of the date of filing.
