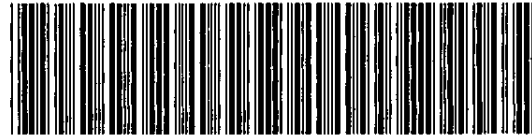

Pursuant to the provisions of Florida Statutes, and following State Department protocol as explained by Ms Karen Ellis of the State's Business Identity Theft Unit, this Florida Not-For-Profit Corporation adopts the following amendments to its Articles of Incorporation, in order to rescind an unauthorized amendment made in a false document filed by six unauthorized individuals on November 22, 2010, through a lawyer, William N. Asma.

AMENDMENTS ADOPTED

ARTICLE V titled: "Directors and/or officers" and the unauthorized amendment adopted on November 15, 2010 is hereby amended as follows:

Husman Bacchus, Sahid Sukhram, Anwar Latib, Wahab Insanally and Izick Jagroop are removed as Directors/Officers of Islamic Center of Clermont, Inc.

It is also adopted that henceforth these individuals may no longer hold any office in this organization, by virtue of the fact that the Florida State Department has determined they committed a 3rd Degree Felony, when they knowingly filed a false document with the Division of Corporations. It is further adopted that no amendments to these Articles of Incorporation or subsequent amendments may be filed with the Secretary of State by any entity except the Board of Trustees.
