Pursuant to a Court Order from Judge Lawrence J. Semento in the 5th Judicial Circuit in and for Lake County, Florida and pursuant to the provisions of Florida Statutes, this Florida Not-For-Profit Corporation adopts the following amendments to its Articles of Incorporation:

AMENDMENTS ADOPTED

ARTICLE V titled: Directors and/or officers" and the amendment adopted on June 19, 2012 is hereby amended as follows:

Husman Bacchus. Sahid Sukhram, Anwar Latib, Wahab Insanally and Izick Jagroop are hereby reinstated as Directors/Officers and may, hereafter, hold any office in this organization. It is further adopted that henceforth, amendments to these Articles of Incorporation or subsequent amendments may be filed with the Secretary of State by them as they see fit.

This amendment seals the Settlement Agreement reached by both parties and approved by Judge Semento in Case No. 12-CA-3728 dated November 26, 2012.


An effort to comply with the Judge's order, by filing an annual report in consultation with Sahid Sukhram to replace the above-mentioned officers, was not satisfactory to all parties, hence this amendment.

Except for officers mentioned herein, all previous members of the governing Board of Trustees voluntarily give up all positions, in

keeping with the spirit of the settlement agreement, which has been sanctioned by Judge Semento in Final Judgment dated November 26, 2012.

This amendment was filed on behalf of **Mohamed N Khan, Imraan Sukhram, Nadeer D Alie and Bibi N Khan to comply with the Court Order heretofore mentioned. No members were entitled to vote on this Amendment.**

FINAL JUDGMENT

THIS CAUSE having come on for hearing on the Joint Motion and Stipulation for Comprehensive Settlement, in Case No: 12-CA-840, Case No: 12-CA-3728, and Case No: 2012-CA-003409, and the Court, being duly advised in the premises, it is

ORDERED AND ADJUDGED as follows:

1. The Defendants, **NADEER D. ALIE, MOHAMED N. KHAN, IMRAAN SUKHRAM, and BIBI N. KHAN**, are hereby permanently restrained and enjoined from the following:
 - (a) ~~That~~ Nadeer D. Alie, Mohamed A. Khan, Imraan Sukhram, and Bibi N. Khan, Defendants in Case Nos: 2012-CA-03409 and 2012-CA-003728 are not and shall not hold themselves out as directors, officers or trustees of Islamic Center of

~~Clermont, Inc. and shall execute such documents as are necessary to identify Husman Bacchus, Sahid Sukhram, Anwar Latib, Wahab Insanally, and Izick Jagroop, as the sole officers, directors and or trustees of Islamic Center of Clermont, Inc.~~

- (b) That the Defendants, or anyone acting on their behalf, shall not prohibit or impede the access to the real property owned by Islamic Center of Clermont, Inc., and its facilities, located at:

15128 Lost Lake Road, Clermont, Lake County, Florida 34711

- (c) Neither the Defendants nor anyone acting on their behalf shall divert mail, open a new mail receptacle or hold mail of Islamic Center of Clermont, Inc., and shall deliver to them any mail now in their possession.

- (d) That Defendants, nor anyone on their behalf, shall represent to any bank or financial institution that they have authority on behalf of Islamic Center of Clermont, Inc. to hold funds, pay funds, pay funds, freeze funds, or perform any banking or financial transactions on behalf of Islamic Center of Clermont, Inc.

- (e) Neither the Defendants or anyone acting on their behalf shall terminate any professionals, consultants or other persons

hired or retained on behalf of Islamic Center of Clermont, Inc.

(f) Neither the Defendants nor anyone acting on their behalf shall negotiate any contracts, satisfy any debt or execute any releases on behalf of Islamic Center of Clermont, Inc.

2. That the Joint Motion and Stipulation for Settlement be and the same is hereby approved and the parties are ordered to comply therewith as though each and every term were set forth herein.
3. All claims by **NADEER D. ALIE** against the **ISLAMIC CENTER OF CLERMONT, INC.**, and **SAHID SUKHRAM**, be and the same are hereby dismissed with prejudice.
4. That the Complaint of **NADEER D. ALIE** and the Counterclaim of **ISLAMIC CENTER OF CLERMONT, INC.** in Case No: 12-CA-840 and the Complaints in Case No: 12-CA-3409 and Case No: 12-CA-3728 are hereby dismissed without prejudice.
5. That **NADEER D. ALIE, MOHAMED N KHAN, IMRAAN SUKHRAM**, and **BIBI N. KHAN**, shall do and perform all acts as set forth in the Settlement Agreement.
6. The Court retains jurisdiction for the purpose of enforcing the comprehensive settlement agreement in this Final Judgment.
