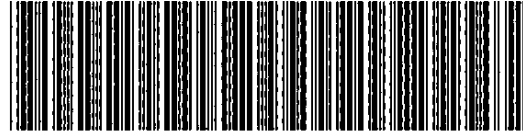

The 9 initial directors have been appointed by the Incorporator. 3 will serve initial 2-year terms, 3 will serve initial 3-year terms, and the 3 directors who will serve on the Executive Committee are appointed for lifetime terms. Once the initial terms have expired, directors will be appointed by the Executive Committee to 2-year terms. Upon the death, resignation, or removal of an initial Executive Committee member, the board will elect a replacement who will serve a term concurrent with the most recently appointed board members.
