ARTICLE I NAME

The name of the corporation shall be: The Southwest Florida Job Squad Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
2020 Queen Street #81 FT. Myers, FL 33917

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

A Not for Profit Corporation to assist job seekers, with disabilities and/or other support needs in Southwest Florida through Individualized Employment Services. This organization is organized exclusively for charitable purposes under section 501(C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Third Article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon dissolution of The Southwest Florida Job Squad Inc., all assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of common pleas of the county in which the principal office is located, exclusively for such purposes or to such organization(s) as said court shall determine which are organized and operated for such purpose.

ARTICLE IV MANNER OF ELECTION

The Initial Board of Directors has been appointed by the Incorporator listed in Article VII.

Subsequent Directors will be elected or appointed by the Initial Directors listed in Article V.
