ARTICLES OF INCORPORATION

OF

A Florida Not-For-Profit Corporation

The undersigned, for the purpose of forming a corporation (the "Corporation) under the provisions of Chapter 617 of the Florida Statutes, hereby adopt the following:

ARTICLE I - NAME

The name of the Corporation shall be: The Conventional and Cosmetic Tattoo Association,
Inc.

ARTICLE II - PRINCIPAL OFFICE
