ARTICLES OF INCORPORATION
OF
THE CONVENTIONAL AND COSMETIC TATTOO ASSOCIATION, INC.

A Florida Not-For-Profit Corporation

The undersigned, for the purpose of forming a corporation (the "Corporation") under the provisions of Chapter 617 of the Florida Statutes, hereby adopt the following:

ARTICLE I - NAME

The name of the Corporation shall be: The Conventional and Cosmetic Tattoo Association, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be: 127 Forest Lakes Blvd., #4, Oldsmar, FL 34677.

ARTICLE III - PURPOSE

The Corporation is a not-for-profit organization and has been organized exclusively for charitable, educational and other purposes as will qualify it as an exempt organization within the scope of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, (the "Code").

Without limiting the generality of the above, the specific purposes of the Corporation shall be:

A. To support the charitable mission of The Conventional and Cosmetic Tattoo Association, Inc., a Florida not-for-profit corporation exempt from taxation under Section 501(c)(3) of the Code;

B. To develop such support through the realization of philanthropic commitments;

C. To educate the community served by The Conventional and Cometic Tattoo Association, Inc., with regard to its present status and its goals for the future;

D. To establish policies and guidelines to attain the foregoing objectives.

ARTICLE IV - TERM OF DURATION

The Corporation shall have perpetual duration.

ARTICLE V - BOARD OF DIRECTORS AND MANNER OF ELECTION

The number of Directors shall be provided in the Bylaws of the Corporation, but shall not be less than three (3). Directors shall be elected, removed and hold office as provided in the Bylaws.

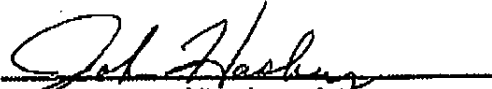
ARTICLE VII - INITIAL REGISTERED AGENT AND STREET ADDRESS
