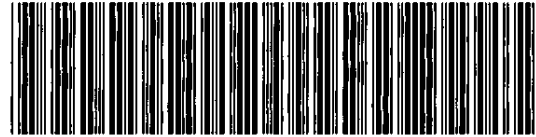

*The undersigned, for the purpose of forming a corporation under Chapter 617 of the laws of the Florida, does hereby adopt the following articles of incorporation:*

**ARTICLE I NAME**

*The name of this Corporation shall be:*

**ARTICLE II PRINCIPLE PLACE OF BUSINESS**

*909 N.E 3<sup>rd</sup> Street Boynton Beach, Florida. 33433*

**ARTICLE III PURPOSE**

*The purpose for which the corporation is to raise funds for Education for low income, economically needed students. To help motivate, provide oppunities for educational advancement for students of Palm Beach County. To receive and maintain funds of real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or part of the income there from and the principles literary, or educational purpose either directly or by contributions under Section 501(c) of the Internal Revenue Code and its Regulations as they now exist or may hereafter be amended.*
