# ARTICLES OF INCORPORATION OF

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a Non-Profit Corporation in accordance with the laws of the State of Florida (Chapter 617, Florida Statutes).

#### ARTICLE I - NAME

The name of this Corporation shall be FAITH FAMILY CHURCH OF MANATEE, INC.

#### <u>ARTICLE II – PRINCIPAL OFFICE & MAILING ADDRESS</u>

The address of the principal office and the mailing address of this Corporation shall be 239 East 301 Boulevard, Bradenton, Florida 34208.

### ARTICLE III - PURPOSE

The general nature and object of this Church shall be the worship of Almighty God, the preaching of the gospel of Jesus Christ unto salvation of the lost, the teaching and instruction of the believers and the development in them of a consistent Christian character, and the promotion of missionary enterprises at home and abroad. In connection with such objects and purposes this Corporation may engage in any lawful act and activity permitted under of the laws of the United States of America and the State of Florida.

# ARTICLE IV - DIRECTORS & MANNER OF ELECTION

The Directors of the Corporation shall be elected in the manner stated and set forth in the Bylaws of the Corporation.

# ARTICLE VI - RESIDENT AGENT & REGISTERED OFFICE

The initial Registered Office of this Corporation shall be located at 1808 – 50<sup>th</sup> Avenue Drive East, Bradenton, Florida 34203, and the initial Resident Agent of the Corporation at such office shall be Wanda Altman. The Corporation shall have the right to change such Registered Office and Resident Agent from time to time in the manner provided by law.

# ARTICLE VIII - BYLAWS

Power to adopt Bylaws of the Corporation or to alter, amend and repeal the same, or to adopt new Bylaws shall be vested in the Board of Directors; provided, however, that any Bylaw or amendment thereto as adopted by the Board of Directors may be altered, amended or repealed by vote of the Members entitled to vote thereon, or a new Bylaw in lieu thereof, may be adopted by the Members, and the Members may prescribe in any Bylaw made by them that such Bylaws shall not be altered, amended or repealed by the Board of Directors.

#### ARTICLE IX - PROPERTY UPON DISSOLUTION

Upon dissolution of the Corporation or winding up of its affairs, the assets of the Corporation shall be distributed exclusively to a religious, charitable, scientific, or educational organization which would then qualify as an exempt organization under Section 501 (c) of the Internal Revenue Code or regulations issued thereunder as the same now exists or may hereafter be amended.
