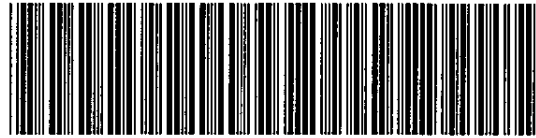

**THE ARTICLES OF INCORPORATION OF PARTI LOUVRY BARYE/BUREAU

**In Compliance with Chapter 617, F.S. (not For Profit)**

The undersigned, for the purpose of forming a not for profit corporation under the laws of the State Of Florida, do hereby adopt the following articles of Incorporation:

**Article I**

**Name**

The name of the Corporation shall be: Parti Louvri Barye/Bureau Politique Regional De La Floride, Inc. The corporation is organized pursuant of the Florida Non profit Corporation Codes

**Article II**

**Article III**

**Purpose**

The specific purpose of this Not For Profit Corporation is for Charitable, religious, and Education training purpose in section 501(c) 3 of the Internal Revenue Code 1986, and for the purpose of engaging in any law act or activity not for pecuniary profit for which Not For Profit Corporation may be organized or permitted by the laws of the State Of Florida and the section 501(c) 3 of the Internal revenue code 1986.


**Article IX**
