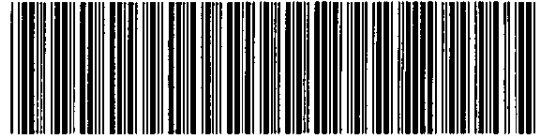

Article I: The name of the Corporation is MOSSEVHA (social movement for the salvage of the children and senior citizen of Haiti). CORPORATION

Article II: The Corporation occurs in Fort-Lauderdale (USA) and has two (2) branches, which are located in USA and Haiti. Its interventions will extend on all the extent from the American and Haitian territory. Its sphere of activities refers to all that is attached to the social activities with no lucrative goal.

This corporation has the objectives to work to the blooming of the individual, to the reinforcement of the community structures, and also to the establishment of a network mutual aid.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c) (3) 01 the Internal Revenue Code, or the corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

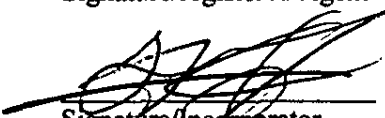
