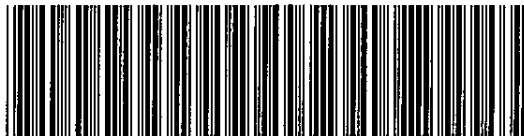

**ARTICLES OF INCORPORATION  
OF  
FAMILY HOME FOR YOUTH OF COLLIER COUNTY, INC.  
(a corporation not for profit)**

THE UNDERSIGNED, acting as sole incorporator of a corporation not for profit to be formed under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation:

**FIRST:** The name of the corporation (the "Corporation") is:

FAMILY HOME FOR YOUTH OF COLLIER COUNTY, INC.

The initial principal office and mailing address of the Corporation is:

Ruskin, Florida 33573

**SECOND:** The term for which the Corporation is to exist shall be perpetual or until such time as the Corporation shall have been dissolved in accordance with the laws of the State of Florida.

**THIRD:** The Corporation is organized for the purpose of providing shelter and support as well as other needed services and assistance to teenagers that generally do not have the opportunity for adoption or placement in a good foster home.

**FOURTH:** The name and address of the initial registered agent of the Corporation shall be:

Ruskin, Florida 33573

**FIFTH:** The management and affairs of the Corporation shall be at all times under the direction of a Board of Directors. No Director shall have any right, title or interest in or to any property of the Corporation. The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.

SIXTH: The name and address of the sole incorporator is:



SEVENTH: Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations qualifying as an exempt organization from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.


EIGHTH: No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements for) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other purpose not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding sections of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

NINTH: Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
