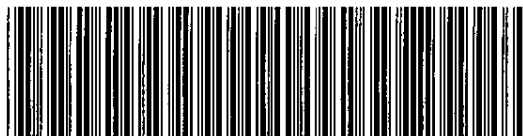

ARTICLE I – NAME

The name of the corporation shall be: **Young Investors Clubs of America, Inc.**

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

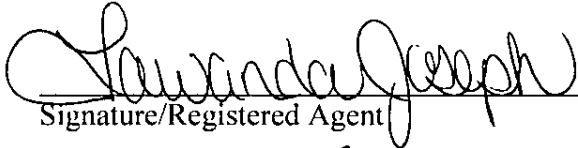

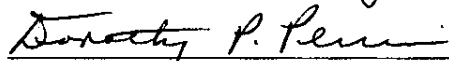
ARTICLE VIII - DISSOLUTION

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized exclusively for such purposes.
