ARTICLE I: NAME

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The name of the corporation shall be: Krumholtz Family Foundation, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 900 S.W. 11th Court, Boca Raton, Florida 33432.

ARTICLE III: PURPOSE
