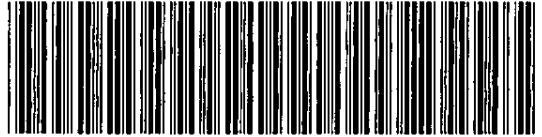

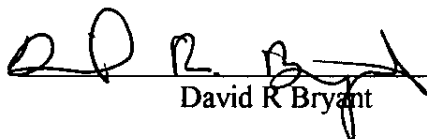

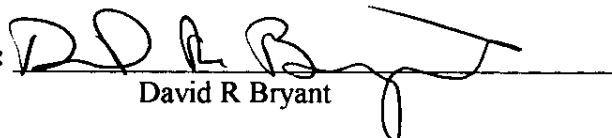
Article VII

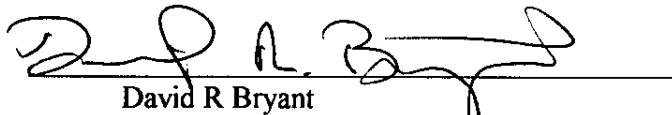

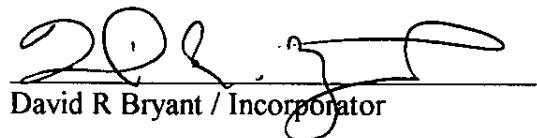
