**ARTICLES OF INCORPORATION
FOR
COMMUNITY ACADEMY FOR YOUTH DEVELOPMENT, INC.**

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

- I. CORPORATION NAME - The name of the Corporation shall be *COMMUNITY ACADEMY FOR YOUTH DEVELOPMENT, INC.*
- II. PRINCIPAL OFFICE – *COMMUNITY ACADEMY FOR YOUTH DEVELOPMENT, INC.* shall have its principal office at 1357 Ovealea Street, Clearwater, Pinellas County, Florida.
- III. PURPOSE - The specific purposes for which *COMMUNITY ACADEMY FOR YOUTH DEVELOPMENT, INC.* is organized are exclusively charitable, educational, cultural, scientific, literary and faith-based within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The *COMMUNITY ACADEMY FOR YOUTH DEVELOPMENT, INC.* will promote youth development programs, family literacy, economic literacy, outreach services, healthy individual/family living and organizational collaboration to enhance community growth that contributes to a safety living environment.
- IV. MANNER OF ELECTION OF DIRECTOR(S)/TRUSTEE(S) - The Director(s) or Trustee(s) shall be elected or appointed as provided in the bylaws of this Corporation.
- V. LIMITATION OF CORPORATE POWERS - Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.


