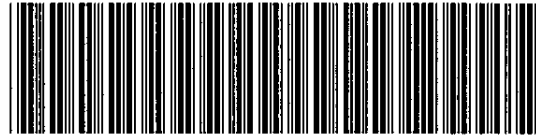



ATTACHMENT TO ARTICLES OF AMENDMENT
OF
FOUNTAIN OF LIFE MINISTRIES INTERNATIONAL, INC.

3. The corporation is incorporated under the Nonprofit Corporation Law of 1988 for the following purpose or purposes:

Said corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code, including:

(a) To disseminate the Gospel of Jesus Christ and the Word of God, to the end that people may be evangelized and believers may be conformed to the image of Jesus Christ (Mark 16:15-16; Isaiah 6:8; Acts 13:47; II Corinthians 5:20); to regularly assemble for fellowship to worship God in Spirit and in truth (Hebrews 10:25) and to cooperate in the building up of the whole body of Christ (Ephesians 2:19-22).

(b) To provide basic New Testament discipleship to all who are approved for this purpose by the Elders. (Acts 6:7, 11:26, 14:20-23)

(c) To establish and maintain a church and to provide a place of public worship and prayer in accordance with the directions of the Holy Spirit (I Kings 8:12-21; Psalm 96:9, 122:1; I Corinthians 5:40); to spread the Gospel of the Lord Jesus Christ through the preaching and teaching of the Bible to bring the unsaved to Christ (Mark 6:15; Romans 1:15-16; I Thessalonians 5:9; II Thessalonians 2:13; II Timothy 3:15), and to build up the saved in Christian grace and living. (Ephesians 4:11-16; Hebrews 3:1-4; I Corinthians 3:9-15) Pursuant thereto, the following activities and guidelines shall be established:

1. A recognized Statement of Faith, Code of Doctrine, discipline and form of worship shall be established. (Acts 8:37, 15:11, 16:31; Romans 4:20-25, 10:9-11; I Thessalonians 4:14-17; I Peter 1:21)

2. A biblical form of government shall be established (Exodus 18; Ephesians 4:8-11; I Corinthians 12:27-31)

3. Ordination of ministers upon completion of the prescribed course of Study, designated by this church. (I Chronicles 9:22-23; Titus 1:5; I Corinthians 7:17; Acts 14:23)

4. An organization of ministers shall be established to minister to the congregation of FOUNTAIN OF LIFE MINISTRIES INTERNATIONAL, INC. (Colossians 4:17; II Timothy 1:16-18; I Corinthians 16:15; Romans 16:1)

5. Establishment of a covenant fellowship based upon acceptance of and conformity to the belief of the church. (Acts 15:41, 16:5)

6. Propagate the Word of the Gospel through seminars, the establishment of Church literature and other forms of mass media for the purpose of educating the individual in the Word of God. (Psalm 96:10; Proverbs 13:17; Mark 13:10; Acts 13:47)

7. Establishment of various religious services pursuant to the recognized Statement of Faith, form of worship, discipline of the church and the establishment of Sunday school and religious schools for Christians and educational instruction of children and adults to exalt the standard of Christian living and the divine leadership of our divine Lord and Master. (Proverbs 8:10, 13:1; Zephaniah 3:7; II Timothy 3:16)

8. Establishment of a Bible Training School or School of Theology for the preparation of ministers who minister to FOUNTAIN OF LIFE MINISTRIES INTERNATIONAL, INC. and to ordain ministers and Christian workers to the edification and the unity of the body of Christ. (Psalm 40:9-10; John 14:26; I Peter 4:6)

(d) To send forth home and foreign missionaries to the spreading of the Gospel and in extending

the Gospel of God throughout the world (Mark 16:15-16; Acts 13:47, 4:29-30).

(e) To support the religious activities of nonprofit religious organizations whose primary objective is to engage in the conduct of religious worship. (I Corinthians 9:9-10, 16:1-4; II Corinthians 9:6-7, 11-13)

(f) To print, publish, and distribute and sell books, magazines and other literature in connection with the purposes of this corporation; to sell, record and reproduce tapes, radio, and television programs in connection with the purposes of this corporation to produce and distribute radio and television programs (Deuteronomy 31:19; I Chronicles 16:23-24; Psalm 68:4; Revelation 14:2).

(g) To establish and maintain a counseling service for the use of the Church and public and to provide access to such counseling service by virtue of telephonic communication (Proverbs 12:15,25, 15:22; Jeremiah 49:20; I Thessalonians 5:14); to assist the body of Christ with employment and financial counseling including off-site Institute of Vocation (Job Training) (I Corinthians 3:8; Colossians 4:1; Ecclesiastes 9:10; I Timothy 6:9-10; John 6:27); A Christians in Human Services Group (I Corinthians 10:24, 12:5; Job 29:16; Luke 6:34; Galatians 5:13, 6:10) and to provide for ministry through Family Services (Deuteronomy 15:7; Nehemiah 8:10; Matthew 5:42; Galatians 6:2; Hebrews 13:16).

(h) To establish and maintain an evangelistic association to spread the gospel of Jesus Christ both in the United States and abroad throughout the world as the Lord leads. (Jeremiah 50:2; Matthew 24:14; Romans 1:16; I Peter 1:24-25; Psalms 51:13; I Corinthians 9:16)

(i) To provide a medical ministry to bring the Word of God and the healing virtue of Jesus Christ to the communities and neighborhoods surrounding the church and throughout the world. (Exodus 15:26; Deuteronomy 32:29; I Corinthians 12:28; Psalms 147:2-3; I Peter 2:24; Mark 16:18; Jeremiah 8:22)

(j) To impact the community around the church by opening the church and its property to activities where the love of God could be exhibited in a non-evangelist setting of community activities. (II Chronicles 17:9; II Timothy 2:24-26; I Timothy 3:7; I Thessalonians 4:12; Isaiah 11:10, 42:6, 60:3, 61:9)

(k) To propagate the Word of the Gospel through seminars, radio, television, establishment of Church literature, and other forms of mass media for the purpose of educating the individual in the Word of God. (Psalms 96:10; Proverbs 13:17; Mark 13:10; Acts 13:47)

(l) To establish and maintain a place where ministry and their families may go to spend time together in a Christian atmosphere conducive to the strengthening of Christian family values and family activities. (Exodus 10:2, 13:8-10; Deuteronomy 4:9-10, 11:19; Psalms 78:3-8; Proverbs 22:6; Isaiah 38:19; I Timothy 3:2,4 5:8; Ephesians 6:4)

(m) To provide home care programs for the members of the church, their families and friends as a way to network the church and its associate ministries. (I Timothy 5:4; Acts 2:46, 5:42, 18:7-11, 20:20; I Corinthians 16:19; Colossians 4:15)

(n) To provide programs to improve the dignity of people residing in areas beset by poverty, drugs and alcohol. (II Timothy 2:25-26; Galatians 6:1; Romans 15:1; I Peter 3:15; I Timothy 2:4)

(o) To provide a prayer ministry to assist those in the church and those in need who need agreement in receiving a touch from the Lord. (Acts 12:5, 14:23, 16:9, 8:22; Isaiah 53:12; Romans 8:27,34; I Timothy 2:1-4)

(p) To establish a family life center where members of the congregation may come for recreational, dietary and nutritional counseling and where children may play in a safe environment. (Ecclesiastes 9:11; Jeremiah 12:5; I Corinthians 6:13,15; II Timothy 2:5)

(q) To equip, maintain and work motor buses or other vehicles appropriate for the transportation of the elderly and low income to their physicians or other places as may from time to time be thought fit.

(r) To conduct Christian retreats, tours, seminars, camps, and to promote the Gospel of Jesus Christ through the various media. (Jeremiah 3:15; Psalms 32:8, 37:30; Proverbs 9:9, 15:22)

(s) To engage in, conduct, promote, advertise and carry on a travel service business, including arranging, planning and booking of worldwide passenger transportation, making reservations at hotels and resorts, making land arrangements for tours and local transportation and conducting tours, on a commission basis or on a buy, sell or charter basis. (Genesis 24:4, 46:28; Exodus 40:34-38; I Samuel 9:18; Matthew 2:1-9; Luke 11:33-35; Acts 8:39-40, 11:13)

(t) To establish and raise up churches and pastors to lead them; to provide spiritual oversight to those churches and pastors who desire the oversight and to provide spiritual accountability for the conduct of independent churches and ministers. (Acts 15:6, 15:22-29, 15:41, 16:5)

(u) To ordain ministers and Christian workers to the edification and the unity of the Body of Christ. (I Chronicles 9:22-23; Titus 1:5; I Corinthians 7:17; Acts 14:23)

(v) To establish and maintain a Lending Library of books and tapes for members of the church who cannot afford to purchase the same (Psalms 68:11; Mark 13:10, 14:7; Romans 12:13; Galatians 6:10; I Timothy 6:18).

(w) To establish an apostolic mission (Matthew 10:7; Luke 9:2; I Corinthians 1:17-18; I Timothy 1:11; Mark 6:13) providing for church planting (Acts 11:21, 15:41, 16:5, 18:8-11), establishing spiritual covering for and authority over members of the five fold ministry and groups seeking association in the fellowship (Acts 15:6,22-29; I Corinthians 4:17, 9:2, 12:28; I Thessalonians 3:1-2), and setting qualified men as recognized by God in the office given them by God (I Timothy 4:14; II Timothy 1:6, 2:2; Titus 1:5; Acts 5:5-6, 13:1-3, 14:23).

To provide for and make available the following on a national and international basis:

1. To promote, foster, encourage and exhort members of the five-fold ministry, ministers, ministries of helps, Christian workers and church workers through instructional seminars and workshops, and fellowship oriented programs in order to perpetrate spiritual growth and increase knowledge, wisdom and understanding, and to provide for a season of refreshing for the whole man, spirit, soul and body. (Acts 15)

2. To certify, license and ordain men of God into positions of ministry and ministry of helps from within and out of the local church based upon calling, education and training and to oversee and evaluate spiritual growth and maturity. (Acts 6:1, 11:29)

(a) To provide for the certification of Christian workers. (I Corinthians 8:4)

(b) To license men called of God as ministries of helps and to provide the proper training, instruction, and education to these men for subsequent entry into the five-fold ministry. (I Corinthians 12:28; Luke 1:54; Acts 20:35; I Timothy 6:2)

(c) To ordain men called of God who are fully trained, thoroughly furnished, and properly educated to assume positions of responsibility in the five-fold ministry according to those endeavors which God has called them to do. (Ephesians 4:11; I Corinthians 12:28)

(d) To review the performance and progress of those previously certified, licensed or ordained, and to renew certifications, licenses, and ordinations based upon spiritual growth and maturity as reflected by experience and progress in the Word of God, and spiritual application of wisdom, knowledge and understanding. (I Corinthians 12:28; Colossians 1:9)

3. To provide and foster continuing education programs as a basis for inspiration, a sharing of information and the dissemination of applicable information and to provide programs of instruction to the benefit of all involved in the Christian faith, and to provide exhortation for the sake of the Gospel, the Kingdom of God and the Christian faith. (II Timothy 1:13, 2:2; Proverbs 9:9)

4. To foster unity among various interdenominational ministries; to provide a forum for exchange of information and ideas concerning the work of the ministry; to periodically hold conventions for members of the five-fold ministry, ministers of helps, Christian workers, and church workers for the purpose of continuing education in how to operate a ministry within the framework of the Kingdom of God, and to provide assistance, guidance and counseling to those working in or relating to any aspect of Christian ministry. (Ephesians 4:12-13; Acts 15)

5. To associate together for the mutual benefit of ministers, clergy, pastors, evangelists, teachers and those associated in any ministerial associations or societies for their mutual benefit as such, and to assist them in the establishment, exhortation and edification of churches, religious organizations, societies and self; to provide continuing education, seminars, retreat and instructional programs to aid and assist in continuing spiritual growth and to disseminate information relative to matters pertaining to the Christian faith and religion. (I Corinthians 14:12; Psalms 37:30; Proverbs 15:22)

6. To accept transfer of other individuals who are ordained by other recognized ministerial bodies, associations and organizations; to interest and unite people of all races, sexes, creeds, and national origins to the end that a nobler manhood and womanhood may be developed and a more perfect love of home, family, country, and church may be fostered.

7. To perpetrate and stimulate the physical and spiritual growth of the local church and to train and assist those within the local church who are called of God into positions of workers, ministries of helps, into the five-fold ministry. (I Peter 4:6; John 14:26)

(x) To conduct praise and worship programs for worship leaders; to conduct college outreach meetings and establish a student center of praise and worship; and to conduct all praise and worship outreach programs necessary to the dissemination of the Word of God throughout the world by way of the song of the Lord (Exodus 15:2, 18:20; Nehemiah 9:5; II Samuel 22:50; II Chronicles 5:14; Psalms 51:15, 69:30, 95:6,8-9, 113:3, 117:1; Jeremiah 31:7; Matthew 5:19; John 4:24; Acts 17:23; II Timothy 2:24).

(y) To carry on charitable work for:

The poor and lost (Leviticus 25:35; Matthew 25:34-40; Galatians 6:10; Mark 14:7)

Feed the Hungry Soup Kitchen, Food Pantry, Clothes Closet (Matthew 25:35;

Psalms 146:7; Luke 3:11, 4:18)

Prison Ministry (Psalm 142:7; I Peter 3:19)

After-care Center for Released Prisoners (Job 3:18; Psalm 69:33; Isaiah 49:9-10)

Sick and Shut-in Ministry (James 5:14-15; Mark 16:18)

Unwed Mother's Home (Luke 1:39-40,56)

Abused Wives and Children's Home (Exodus 22:22-24; Deuteronomy 10:18; Acts 6:1; I Timothy 5:3-12,16)

Housing for the Homeless and Runaways (Leviticus 25:35; Proverbs 19:17; Luke 3:11; II Corinthians 8:14-15)

Care for and assist handicapped individuals (Leviticus 19:32; Isaiah 35:5; Mark 7:37; Luke 7:32,14:13-14)

To provide ministry to homosexuals and prostitutes, so they may be taught the Gospel of Jesus Christ (I Corinthians 1:27-31, 6:9-11; Hebrews 10:22; Luke 14:12-14; Matthew 22:2-10, John 8:1-11).

To provide homes for the aged (Leviticus 19:32; Psalm 71:9; Isaiah 45:20-22).

To provide child placement services and adoptive services (Psalm 127:3; Isaiah 54:1; Mark 10:14; Numbers 3:13).

To establish a credit union for members of the church (Psalm 72:4, 112:5; Malachi 3:10; Deuteronomy 15:7-11, 28:12,44; Matthew 5:42; Proverbs 3:9; Nehemiah 11:38).

Housing for those with addictive behavior (Luke 4:18).

Drug and Alcohol Program (Isaiah 5:11, 19:14,20; Habakkuk 2:15; Joel 2:32; Matthew 9:12; Psalm 121:2).

The mentally disturbed (Matthew 4:24, 17:15).

(z) To provide food and clothing for those in need through direct grants and through discount stores whereby the needy may purchase food at reduced rates. (Acts 11:29; Psalms 72:12-13, 146:7; Isaiah 41:17, 58:7; Matthew 25:35-40; Ezekiel 18:7, 45:10-12; Deuteronomy 15:7-8, 25:13-16; James 2:15-65; Luke 3:11; Proverbs 11:1, 26, 16:11)

(aa) To provide homes for the aged (Leviticus 19:32; Psalms 71:9; Isaiah 45:20-22); to provide retirement homes for the faithful ministers and saints (Numbers 8:24-26; Zechariah 8:4); to care for the aged (Leviticus 19:32; Psalms 92:14; I Timothy 5:1,17), and to provide housing for the working staff of the church (Joshua 21:1-8; Acts 4:34-35).

(bb) To provide housing through new construction and renovation for those who are not otherwise able to afford such housing (Numbers 32:24; II Kings 6:1-2; I Kings 9:17-18; Leviticus 25:29-31; Isaiah 65:21; Jeremiah 29:5).

(cc) To establish and maintain an educational institution and not for pecuniary gain; for the establishment, maintenance and support of a private Christian elementary and secondary schools (Christian Academy) at which both charity and pay students shall be received; for the establishment, maintenance, and support of a private Christian day care center and nursery school (Mark 10:14; Luke 18:16-17) at which both charity and pay students shall be received.

(dd) To establish and maintain a theological college of higher education and training in the Bible, Biblical languages, Christian theology and literature and such training in the mathematics, history, science, languages and scripture as are needful and appropriate to the education and training of ministers of the Gospel and missionaries in foreign and home fields, Bible teachers, and other Christian workers in various lines of religious, benevolent and philanthropic work. The institution shall grant appropriate degrees and provide for the proper regulation and control of its students. The institution shall offer admittance and equal advantages to all students who possess the requisite literary, moral and other qualifications, irrespective of their particular denomination or religious profession and both charity and pay students shall be used to extend the charity work, but not part of the income shall be received, wherein the income from the pay students shall be used to extend the charity work, but not part of the income shall ever be paid or distributed to its members, directors or officers, other than reasonable compensation for services rendered. Such institutions within the church shall have a racially nondiscriminatory policy towards students and shall not discriminate against applicants and students on the basis of race, color and national or ethnic origin. (Psalms 40:9-10; John 14:26; I Peter 4:6; II Timothy 2:2,24-25; I Corinthians 14:12)

(ee) To establish and maintain a Christian bookstore for the benefit of the students and members of the Church and their guests (Psalm 68:11; Acts 13:39).

(ff) To provide tripartite therapeutic counseling for the spirit, mind and body. (I Thessalonians 5:23; I Corinthians 6:20; Jeremiah 42:4; Psalms 25:9); to cooperate with the church in the building up of the whole body of Christ. (Ephesians 2:19-22)

(gg) To send home and foreign counselors to bring forth the consultation of 'third world' and 'cross-cultural' counseling throughout the world. (Mark 16:15-16; Acts 13:47, 4:29-30)

(hh) To provide Christian Mediation and Intervention services to those within the church and Body of Christ at large. (II Corinthians 5:18-19; Galatians 3:20; Proverbs 15:1; Ephesians 6:18; Hebrews 7:25; I John 5:16; II Kings 22:13)

(ii) To own and operate Radio and Television Stations for the purpose of the dissemination of the Gospel of Jesus Christ through word and music (Psalms 96:10; Proverbs 13:17; Mark 13:10; Acts 13:47; Deuteronomy 31:19; I Chronicles 16:23-24; Psalms 68:4; Revelation 14:2)

(jj) To assist churches, ministers and ministries in the dissemination of God's word through the various avenues of media and to provide quality service of such to its Body of Christ. (Isaiah 41:6; Numbers 11:17; 32:17-22; Acts 18:27, 31-32; I Corinthians 16:16)

(kk) To manufacture, distribute and sell audio records and magnetic tape cassettes, compact discs or other mechanical or electronic recordings; to manufacture, distribute, produce and sell video tapes of all types of music, ministry, preaching, teaching, etc.. (Psalms 22:27, 66:4, 67:4, 68:4; Deuteronomy 31:19; I Chronicles 15:16, 16:23-24; Revelation 14:2)

(ll) To conduct pastor training seminars for national pastors; and to conduct all missionary outreach programs necessary to the dissemination of the Word of God throughout the world. (Luke 6:40; Psalms 32:8; Proverbs 1:5)

(mm) To establish *auxiliaries, clubs, and societies of a religious nature and to promote and encourage* Christian fellowship between its members (Acts 15:41, 16:5)

(nn) To print, publish, distribute and circulate on a national and international basis, books, pamphlets, periodicals, papers, newsletters, and magazines in connection with the kingdom of God and the propagation of the Gospel of Jesus Christ. (Psalms 68:11; Acts 13:49; Exodus 31:18; Mark 1:45, 13:10)

(oo) To establish churches, church schools, missions, Christian camps, Christian Centers, Radio and TV programs and stations, both at home and abroad, and Christian Academic institutions, to standards set forth by the New Testament. (Acts 15:41, 16:5; Proverbs 8:10, 13:1; II Timothy 3:16; John 14:26; I Peter 4:6; I Chronicles 16:23-24; Psalms 68:4; Revelation 14:2)

(pp) To conduct pastor training seminars for national pastors; and to conduct all missionary outreach programs necessary to the dissemination of the Word of God throughout the world. (Luke 6:40; Psalms 32:8; Proverbs 1:5)

(qq) To develop, implement, administer and promote faith based humanitarian and social service projects of a religious, educational and charitable nature (I Corinthians 10:24, 12:5; Job 29:16; Luke 6:34; Galatians 5:13, 6:10). *The corporation shall obtain, analyze and distribute information and resources exclusively for the use of those projects, and activities stipulated herein, within the framework of the Corporation.*

(rr) To provide social service programs including:

(1) To provide targeted members of the Community, especially the elderly (Leviticus 19:32; Psalm 71:9; Isaiah 45:20-22) and low to moderate income families, with affordable housing facilities and services specially designed to meet their physical, social and economic needs, and to assist in eliminating poverty among all citizens. (Leviticus 19:32, 25:35; Ezra 8:28; Psalm 92:143; Proverbs 19:17; Luke 3:11; II Corinthians 8:14-15; I Timothy 5:1)

(2) To provide a child care agency to include a foster care agency, foster care boarding homes, child placement services and an adoption services for those desiring to adopt children and those desiring to place their children with a good family (Numbers 3:13; Psalms 127:3; Isaiah 54:1; Numbers 3:13).

(3) To provide foster care services for emotionally disturbed children and other special children who are having a difficult time with their current situation (Mark 10:14).

(4) To establish and provide a personal care home for individuals who may need brief placement of their incapacitated loved ones (Luke 10:34; I Corinthians 9:9).

(5) To establish and operate facilities which will engage in drug and alcohol rehabilitation programs. (Psalm 121:2; Isaiah 5:11, 19:14-20; Habakkuk 2:15; Joel 2:32; Matthew 9:12)

(6) To organize a "Meals on Wheels" program for those who cannot cook for themselves and those who are otherwise in need of such a service. (Matthew 25:35; Luke 4:18)

(7) To provide care, housing and other assistance for transitional persons, runaways and the homeless (Leviticus 25:35; Proverbs 19:17; Luke 3:11; II Corinthians 8:14-15).

(ss) In addition to the above purposes, the corporation shall have the following powers:

A. Borrow money, make and issue notes, bonds and other instruments of indebtedness of all kinds, whether secured by mortgage, pledge or otherwise; without limit as to amount, except as may be prohibited by statute or code, and to secure same by mortgage, pledge or otherwise; and to make and perform agreements and contracts of every size and description:

B. To conduct and carry on its business, or any part thereof, and to have one or more offices, and to exercise all or any of its Corporate powers and rights in the state of Pennsylvania, and in the various states, territories, colonies, and dependencies of the United States, in the District of Columbia, and in all or any foreign countries or country. Receive donations, gifts and contributions, for specific and/or general projects and to accept grants and bequests to the extent and as allowed under the statutes of the state of Pennsylvania.

C. To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein above set forth, either alone or in association with other Corporations, firms or individuals, and to do every act or acts, thing or things, connected with the aforesaid business or powers, or any past or parts thereof:

Provided, the same be not inconsistent with the laws under which this private, nonprofit Corporation is organized.

D. To designate its own officers, to appoint committees, to arrange for its own meetings and to govern itself in accordance with the Bylaws.

E. To hire and employ agents, servant, and employees, and to enter into agreements of employment and collective bargaining agreements and to act as agent, contractor, trustee, factor or otherwise, either alone or in company with others.

F. To purchase, to receive by way of gift, subscribe for, invest in, and in all other ways, acquire, import, lease, possess, maintain, handle on consignment, own, hold, or investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, let, lend, report, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal or mixed, tangible or intangible wherever situated and however held, including, but not limited to money, credits, chooses in action, securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, notes, commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm, or documents of title, and accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products and avails thereof and every character of interest therein and appurtenance thereto including but not limited to, mineral, oil, gas, and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof and any interest in or part of any of the foregoing and to exercise in respect thereof all of the rights, powers, privileges and

immunities of individual owners holders thereof (Ezra 8:28)

G. To receive tithes, offerings, and property by gift devise or bequest subject to the laws relating to the transfer of property by gift or will. (Acts 4:34-37; II Chronicles 31:3-7; Leviticus 27:30; I Corinthians 16:1-2; Luke 6:38)

H. To operate under the name as set forth in Article I above; to adopt and assume names in the furtherance of its nonprofit, tax-exempt purposes (Genesis 17:5, 32:28; Acts 13:9; Matthew 1:23; Revelation 2:17); to exercise such other and incidental powers as may reasonably be necessary to carry out the purposes for which the church is established, provided that such incidental powers shall be exercised in a manner consistent with its tax exempt status as a religious organization as set forth in Section 501(c)(3) of the internal Revenue Code of 1986 as amended, of the United States of America.

The several clauses contained in this Article shall be constructed both as purposes and powers and powers and the statements contained in each clause, shall except where otherwise expressed, be in no wise limited or restricted by reference to or inference from the terms of any other clauses, but shall be regarded as independent purposes and powers.

I. To join, merge or unite with any other church or religious society having the same ideals, aims and purposes of this church; to associate and cooperate freely with other churches and with missionary organizations and branches as a free and independent fellowship body in accord with its own conscience and the wisdom of God, as the church perceives it to be, but in every case and in every act and in practice or association does and shall do so as a free church, always retaining its sovereignty and independence, and in no case whatsoever as an act of subjection nor precedent or amenability nor as an active or passive or implied affiliation nor in any as relinquishing its perpetual legal independence and sovereignty as a church. (Acts 5:12-14; I Corinthians 1:10, 6:17; Ephesians 4:16)

J. To act as Trustee under any trust incidental to the principal objects of the church and to receive, hold, administer and expend funds and property subject to such trust. (Acts 4:34-37)

K. To acquire, hold, own, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock, bonds, obligations or other securities of other corporations, domestic or foreign, as investments or otherwise, in carrying out any of the purposes of the church and while the owner thereof, to exercise all rights, powers and privileges of ownership, including the power to vote thereon.

L. To employ qualified counsel and other necessary personnel to carry out the purposes of this church. (Titus 3:13; James 5:4)

(tt) To further all religious and charitable work and for such purposes to adopt and establish Bylaws, rules, regulations in accordance with the law and not inconsistent with this Articles of Incorporation. (Joshua 1:7-8; Habakkuk 2:2-3; Romans 7:12, 10:4)

(uu) To do all those things allowed and permitted to be done under law and specifically those set forth in the Pennsylvania Nonprofit Corporation Code.
