

### ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

#### THE FCRA EDUCATION FOUNDATION, Inc.

The undersigned, a natural person of the age of eighteen or more, acting as incorporator for the purpose of creating a nonprofit corporation pursuant to Chapter 617, Florida Statutes (F.S.), adopts the following Articles of Incorporation for such corporation:

Article I: The name of the corporation (hereafter called the Corporation) is The FCRA Education Foundation, Inc.

Article II: The principal place of business and mailing address of the corporation is:

8022 Alafia Ridge Rd, Riverview, Florida 33569

Article III: The period of duration of the Corporation shall be perpetual.

Article IV: The Corporation is organized and shall be operated exclusively for charitable, educational and scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (the "Code"). In Furtherance of these purposes, the Corporation shall conduct and support educational and scientific activities related to the collection, management, and analysis of data on persons with the diagnosis of a malignant or neoplastic disease; work to ensure the public availability of such data; conduct and support research activities related to the etiology, diagnosis, treatment and registry of cancer; conduct and support fundamental research on the epidemiology of cancer; and support the efforts of local, state and national cancer agencies relating to the above.

Article V: The election of directors shall be as provided for in the bylaws.
