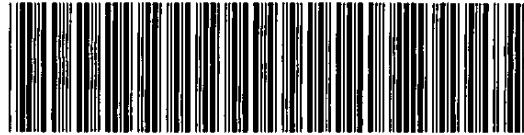

The undersigned, for the purpose of forming a for-profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **Esther's Daughters Ministries International, Inc.** (hereinafter called the "Corporation").

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the corporation is **3011 N.W. 183rd Street, Miami, Florida 33056.**

ARTICLE III
PURPOSE

The specific purpose of this not for profit corporation is for the charitable, religious and educational training purposes in Section 501(c) 3 of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not for profit corporation may be organized, so far as is or may be permitted by law of the state of Florida and Section 501(c) 3 of the Internal Revenue Code 1986 as amended. Also, there will be several outreach programs organized to operate through Esther's Daughters Ministries International, Inc. such as: Kingdom Building Leadership Training (K.B.L.T.); Beauty Enhancement Program (B.E.P.); Technology Outreach Program (T.O.P.); Women Support Group Outreach (W.S.G.O.); Entrepreneurship, Retreats, Workshops; Preparation Before Marriage (P.B.M.); Personal Development; Health Issues Outreach (H.I.O.); Esther's Daughters International Network Alliance (E.D.I.N.A.); Esther's Daughters Radio Ministries (E.D.R.M.); Youth Empowerment Program (Y.E.P.); Singles Mentoring Program (S.M.P.); Women Fellowship Outreach (W.F.O.); Spiritual Development Program (S.D.P.); Bible Enrichment Studies (B.E.S.); Evangelist Outreach Program (E.O.P.); Esther's Daughters Safe Haven For Children (E.D.S.H.F.C.); Intercessory Prayer Connection (I.P.C.); Licensing & Ordination Program (L.O.P.); Counseling Outreach Services (C.O.S.); Esther's Daughters Annual Banquet (E.D.A.B.); Christian Consulting Services (C.C.S.); Etc.

ARTICLE IV
INITIAL REGISTERED OFFICE AND AGENT

The street address of the Corporation is **3011 N.W. 183rd Street, Miami, Florida 33056.** The initial registered agent shall be **Bishop Dr. Daisy N. Jones.**

ARTICLE V
BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than (4) four directors. The number of the directors may be increased or decreased from time to time, in accordance with the laws of the Corporation, but shall never be less than (4). The manner of election of directors shall be regulated by the laws.


ARTICLE VII
DISSOLUTION

Upon the dissolution or winding up of this Corporation, its assets remaining after payment or provisions for payment of all debts and liabilities of the Corporation shall be distributed to a not-for-profit fund, foundation, or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(C) 3 of the Internal Revenue Code 1986, as amended, or corresponding provision of any subsequent federal tax laws.

ARTICLE VIII
LIMITATIONS

No part of the net earning of the Corporation shall inure to the benefit of, or be distributed to its Director, Officers, Members, or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).


