CHURCH CONSTITUTION

PREAMBLE

So that things may be done decently and in order, in accordance with the accepted tenets of other churches of like precious faith, and so that we may more readily help each other in our Christian service, we declare and establish this constitution to which we voluntarily submit ourselves.

SECTION 2 – PURPOSE

- A. This congregation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, print shops, day-care centers, camps, nursing homes, cemeteries, and any other ministries that the church may be led by God to establish.
- B. The church shall also ordain and license men and women to the gospel ministry; evangelize the unsaved by the proclaiming of the gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of Holy Scripture, both in sunday and weekday schools of christian education; maintain missionary activities in the United States and any foreign country; and engage in any other ministry that the church may decide, from time to time, to pursue in obedience to the will of God.
