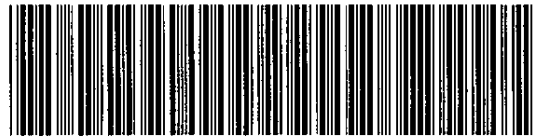



**ARTICLES OF INCORPORATION**

**In Compliance with Chapter 617, F.S. (Not for Profit)**

**ARTICLE I: NAME**

The name of the corporation shall be FAMILY DEVELOPMENT ACADEMY, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

3764 West 12<sup>th</sup> Avenue, Hialeah, Florida 33012

**ARTICLE III: PURPOSE**

The purpose for which this corporation is organized AS A **NOT FOR PROFIT** is to provide affordable quality day care services and educational services (after school programs) to children of low income communities whose parents generally work for minimum or low wages rather than receive public assistance.

**Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501© (3) of the IRC code, or corresponding section of any future federal tax code.**

The Family Development Academy, Inc. also aims to strengthen the total well-being of the families in our community through supportive services and encourage parental participation in the educational process of their children.

**ARTICLE IV: MANNER OF ELECTION**

##### **LIMITATIONS IN USE OF NET EARNINGS AND ACTIVITIES**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorize and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of



this document, the organization shall not carry on any other activities not permitted to be carried on

- i. By an organization exempt from federal income tax under section 501 (c) (3) of the IRS code or
- ii. By an organization, contributions to which are deductible under section 170 ( c ) ( 2 ) of the IRS Code, or corresponding section of any future tax code

#### **ARTICLE IX:**


#### **DISSOLUTION OF THE NON FOR PROFIT ORGANIZATION INCORPORATOR**

In the event the organization be dissolved or liquidated, assets shall be distributed for one or more exempt purposes within the meaning of section 501 ( c ) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.






