### ATTACHMENT TO ARTICLES OF INCORPORATION OF BETHEL PRAISE CENTER INC.

ARTICLE III PURPOSE: This Corporation shall be a nonprofit contractant OF STATE. The purpose for which Bethel Praise Center Inc. is organized is exclusively as a public on religion, a subject useful to the individual and beneficial to the community and advance religion within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE VIII: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IX: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
