ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, for the purpose of forming a nonprofit Corporation under the Florida Not For Profit Corporation Act, Florida Statutes, Chapter 617, makes and adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the Corporation is as follows: ONIKUSU Judo Club, Inc.

ARTICLE II

Principal Office

The principal place of business and mailing address of the corporation is 3531 NW 43rd Place, Fort Lauderdale, FL 33309.

ARTICLE III

Purposes

The primary objective of ONIKUSU Judo Club, Inc. is to provide community-based social services to at-risk kids in Broward County. ONIKUSU Judo Club, Inc. provides services, which are aimed at preserving, enhancing, and restoring the quality of life for youth through the county.

ONIKUSU Judo Club, Inc. is organized exclusively for charitable, religious, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation may receive and administer funds for religious, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, ONIKUSU Judo Club, Inc. is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such a manner as, in the judgment of the directors, will best promote the purposes of ONIKUSU Judo Club, Inc., without limitation, except limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of ONIKUSU Judo Club, Inc., or any applicable laws, do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law.

No part of the net earnings of the ONIKUSU Judo Club, Inc. shall inure to the benefit of any member, trustee, officer of the ONIKUSU Judo Club, Inc., or any private individual, except that reasonable compensation may be paid for services rendered to or for the ONIKUSU Judo Club, Inc. affecting one or more of its purposes, and no member, trustee, officer of the ONIKUSU Judo Club, Inc., or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the ONIKUSU Judo Club, Inc.

No substantial part of the activities of the ONIKUSU Judo Club, Inc. shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the ONIKUSU Judo Club, Inc. shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV Dissolution

On the dissolution of the ONIKUSU Judo Club, Inc., the board of directors shall, after paying or making provision for the payment of all of the liabilities of the ONIKUSU Judo Club, Inc., distribute all of the assets of the ONIKUSU Judo Club, Inc. exclusively for charitable, scientific or educational purposes in such manner and to such qualified organization or organizations as the board of directors shall determine. Any of the assets not so distributed shall be distributed in accordance with the direction of any court having jurisdiction in the county in which the principal office of the ONIKUSU Judo Club, Inc. is then located, exclusively for the above purposes of the ONIKUSU Judo Club, Inc. or to a qualified organization or organizations as the court shall determine. For purposes of this article, an organization is a "qualified organization" only if, at the time of receiving the assets, it is operated exclusively for the purposes described in 26 U.S.C.A. § 170(c)(1) and is described in 26 U.S.C.A. § 509(a)(1), (2) or (3).
