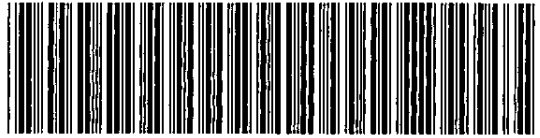





**THE UNDERSIGNED** Incorporator(s), for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I NAME**


