

The purpose(s) for which this Corporation is formed exclusively for Religious, Charitable, Scientific, Literary and Educational which shall operate within the full meaning of Section 501© (3) of the Internal Revenue Code of 1986 and or within the corresponding provision of any future US Internal Revenue Code and or laws which consider the separation of Church and State within the spirit, intent and purposes of the United State Constitution.

Admitting of Membership:

Any asset (s) to be disposed of shall only serve the interest of the religious organization in some complex cases the Board of Trustees may seek the assistance and or advise of appropriate governmental agency (ies) within the County where the office of the religious organization is located.


