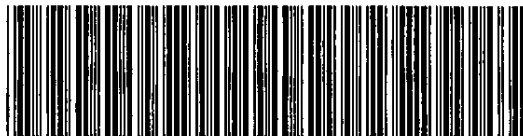


ARTICLE IV

The effective date of the dissolution shall be upon the filing of the Articles of Dissolution with the Florida Department of State.




